These services are delivered by a team of experienced consultants with an expansive range of skills and subject-matter expertise. Frequently requested consulting services include strategic planning, organizational assessment, fundraising enhancement, and human resources management. Our Executive Search and Transition Management Services (ESTM) provide all of the strategic elements to make a change in leadership successful.

Professional Development: Research indicates that professional development is an essential means to reducing turnover, increasing effectiveness, and strengthening organizations. Greater organizational durability is embodied in enhanced skill building, expanded knowledge base, heightened morale, and increased employee motivation and loyalty. The Support Center conducts more than 175 workshops, forums, and panels annually - reaching over 2,200 nonprofit staff and leaders - to build nonprofit leadership, fundraising, management, marketing, technology and board building skills. Workshop design ensures that nonprofit staff learn and gain support from each other.
